

RESOLUTION No. 16-2018
Harrisburg Redevelopment Authority

WHEREAS, the Redevelopment Authority of the City of Harrisburg (“Authority”) wishes to conduct Urban Renewal and Economic Development activities achieved through De-Channelization of the Paxton Creek from Herr Street to Berryhill Street in Harrisburg, Pennsylvania,

WHEREAS, “*Paxton Creek De-Channelization – 2018 Acquisition and Construction*” Project in Dauphin County ("Project") is bounded by the Mulberry Street to the South, Cameron Street to the East, S. 10th Street to the West, and Walnut Street to the North; and

WHEREAS, the Project involves acquisition of the following properties and demolition and removal of the following structures to accommodate De-Channelization:

1. Mulberry Street
 - a. East Bound: remove concrete slab bridge, and
 - b. West Bound: remove pre-stressed concrete adjustable box beam bridge
2. Acquisition and removal of parking lot spanning Paxton Creek at 1006 Market Street.
3. 1021 Market Street: Acquisition and demolition of a cantilevered facility
4. Demolition of facility on 28-38 Cameron Street.
5. Purchase of 29 & 65 S 10 Street
6. Paxton Creek Interceptor Rehabilitation by Capital Region Water as a match activity

WHEREAS, the Authority submitted an application to the Commonwealth of Pennsylvania for Redevelopment Assistance Capital Program (RACP) funding for the Project; and

WHEREAS, on May 29, 2018, the Commonwealth has authorized the release of a portion of those RACP funds, in the amount of \$2 million for the Project; and

WHEREAS, the Office of the Budget of the Commonwealth of Pennsylvania requires that such grants be awarded to local governments units or municipal authorities; and

WHEREAS, it is deemed to be to the mutual benefit of the City of Harrisburg, the County of Dauphin, and the Commonwealth of Pennsylvania to construct the Project in the City of Harrisburg and County of Dauphin, Pennsylvania; and

WHEREAS, the Redevelopment Authority of the City of Harrisburg is a body politic and corporate organized and existing under the laws of the Commonwealth of Pennsylvania; and

WHEREAS, Authority is agreeable to be the Applicant to make application to the Commonwealth of Pennsylvania, to deliver RACP funds to the Project;

NOW, THEREFORE, BE IT RESOLVED, that Redevelopment Authority of the City of Harrisburg approves the application for a Redevelopment Assistance Capital Program funds in the amount of \$2,000,000 to the Office of the Budget of the Commonwealth of Pennsylvania, by this Resolution for the purpose of executing the Project in the City of Harrisburg and County of Dauphin, Pennsylvania as set forth herein above.
